

Hydrocap 90FR-M is not intended to be used as the finished surface of the roof. It can be left exposed for periods up to 9 months.



Additional protection is normally required in traffic areas and where physical abuse is anticipated.

Hydrocap 90FR-M is available in roll form, with a width of 39.76 inches (1 m) and a length of 33.3 feet (10.15 m). One roll equals approximately 100 square feet (9.3 sqm) of coverage.
